If not pre-paid-in-full, the "Reservation Deposit" is required in the amount of **\$1600** (unless otherwise prior-specified) - which will be applied towards the final purchase price.

### The Buyer and JOVAL Agree to the following:

- Deposits are **NON-REFUNDABLE** and will not be returned if you change your mind. "**BACKING OUT**" at **ANY STAGE** of this process or **FAILURE TO PICK UP A PUPPY AS SCHEDULED** may result in the imposition of "late fees" or the forfeiture of any or all of any monies deposited. This determination will be made at the sole reasonable discretion of JOVAL.
- Deposits are, however, may be **TRANSFERRABLE** to a subsequent litter where availability exists. This transfer must be done by prior-arrangement and will be reasonably approved on a case-by-case basis at the sole discretion of JOVAL.
- Should something happen to the reserved puppy, another puppy from a future litter shall be offered and the deposit will transfer to that litter. In the circumstance when a puppy is offered from a future litter, there is no timeframe allotted; it is dependent on availability.
- The vast majority of our puppies are NOT sold under Full registration, and NOT eligible for breeding or confirmation showing unless otherwise agreed to in writing and stipulated under a \*specifically customized contract\*. Agility, Rally & Obedience competitions are perfectly acceptable for companion dogs sold under contract specifying they are eligible for Limited registration. Any/all registrations of litters & eligible puppies with any dog registry are performed at the sole discretion of JOVAL, costs for any/all registrations are at buyer's sole expense.

- All puppies remain the sole personal property of Joval Kennels until i) the purchase price (above) payment is received IN FULL including required sales taxes, ii) associated fees (required) for microchip & AKC registration(s) have been received IN FULL and iii) the original Sales Contract has been received - having been executed by the Buyer(s) before a notary (bearing their signature and seal).
- As a condition of consideration for receiving a JOVAL puppy, all potential buyers acknowledge and agree to abide by the breeder's reasonable request to NOT PUBLICLY POST pictures, descriptions, correspondences or details of the puppies on any social media platform or to communicate this information with other breeders. Failure to comply may result in JOVAL's decision to remove you from consideration for purchasing a JOVAL puppy.
- **JOVAL Kennels reserves the right not to sell a puppy to anyone and for ANY reason.**  
This includes but is not limited to our wish to retain the puppy for our breeding program; we have found a home that we feel is more suitable for a specific puppy; we have learned new information regarding your application that gives cause for reconsideration; or we have reason to believe that the final payment is fraudulent or invalid.
- If for ANY reason JOVAL, at our sole discretion, decide not to complete the transaction, we will promptly refund your deposit(s) in full.
